

We, the undersigned, residents of the State of Washington, do hereby associate ourselves together with the intention of forming a corporation under Chapter 6 of Title 25 of Remington's Revised Statutes of said state, as amended, and in furtherance thereof do hereby make, sign and declare the following.

ARTICLE I

The name of this organization shall be:

EAST SOUND WATER USERS ASSOCIATION.

ARTICLE II

The purposes for which this corporation is formed are to furnish water to its members and others, and to do all things useful or desirable to that end, including but not by way of limitation, the operation of water systems of every kind, the construction, reconstruction and acquisition in any fashion of reservoirs, wells, pumps, water lines, and water rights, the maintenance of flumes, lines and works to convey and furnish water for every purpose or use, and all things incidental thereto; to acquire franchises, easements, rights-of-way, property, by purchase, gift or condemnation as provided by law; and the exercise of all powers granted to the corporation by law. The corporation shall render no service to or for the public.

ARTICLE III

The principal place of business of the corporation shall be $\mathsf{E} : \mathsf{st}$ Sound, Washington.

ARTICLE IV

The existence of this corporation shall be perpetual.

ARTICLE V

The affairs of the corporation shall be managed by a Board of not less than five (5) trustees. Until the by-laws shall provide otherwise there shall be seven (7) trustees, and the names of the trustees who shall manage the affairs of the corporation for the first three months following completion of its organization are:

ARTICLE VI

The members of the corporation shall consist of the said trustees, together with H. F. Furrow, Howard Porter, and Carl Webber, , who shall be charter members hereof, plus such other persons as may be accepted as additional members under such conditions, and subject to such approval as may be fixed by the by-laws. The rights of all members shall be subject to these articles, the by-laws and all orders and regulations made pursuant thereto. and to all contracts entered into by the corporation. No

additional members shall be accepted nor water furnished to any additional persons at any time if such expansion of the membership or the furnishing of such additional water would in any way jeopardize the furnishing of an adequate supply of water to the then existing members of the corporation for ordinary domestic use, including domestic garden irrigation.

ARTICLE VII

By-laws shall be adopted at the first meeting of the membership for the government and management of the corporation and its affairs. The by-laws may thereafter be amended, repealed or added to by the Board of Trustees, subject to the right of the membership by affirmative vote of a majority of the whole membership to amend, repeal or add to the by-laws.

ARTICLE VIII

The by-laws may authorize the Board of Trustees to fix all water rights, charges and fees of every kind in connection with the furnishing of water or water service, and to fix such conditions as the board may think proper for installation and connections for water service.

ARTICLE IX

This corporation shall have no capital stock and no dividends or pecuniary profits shall be declared or accrue to the members thereof; PROVIDED, advancements or loans may be made to and received by the corporation for the furtherance of its purposes, and provision may be made by the Board of Trustees or the by-laws for the re-payment of such loans or advancements with interest; and provided further that surplus funds accumulated from fees or charges paid by members may be distributed among the membership as provided by the by-laws.

Membership Agreement

Impact Units

This Membership Agreement describes the duties and obligations of Eastsound Water Users Association (Eastsound Water) and the Water User who connects to Eastsound Water for the purposes of obtaining water. San Juan County has designated Eastsound Water as the sole provider of water within the Eastsound Water service area. As the sole provider of water, Eastsound Water is obligated to provide water, insomuch as it has the capacity to do so, to all consumers of water within the service area, and to do so without discrimination.

Eastsound Water is a member-owned cooperative. Eastsound Water acts through an elected Board of Directors, which manages the affairs of the cooperative. All revenues are used to provide water to Members within the service area while maintaining and operating the system in compliance with applicable legal standards.

Definitions

- Water User: Any individual or legal entity authorized to obtain water through an Eastsound Water account
- Member: A Water User whose application for membership in Eastsound Water has been accepted by the Board of Directors

- Membership: The Members collectively as a group, which acts through an elected board of directors
- Impact Units: A term used by Eastsound Water to allocate the costs of developing water system capacity and the costs of operating and maintaining the water
- ERU: A term used by the Washington Department of Health when determining the total water capacity available to Eastsound Water.

Requirements of a Membership Agreement

- 1. There will be one unique Membership Agreement for each tax parcel for which Eastsound Water delivers water
- 2. The applicant must own the described property and it must be within the Eastsound Water service area
- 3. A Membership Agreement requires approval by the Board at a regular meeting or by such persons as the Board may designate
- 4. The applicant will provide a notarized easement for any and all Eastsound Water water system infrastructure on their property on forms supplied by Eastsound Water. The easement will be recorded by Eastsound Water

Duties of Eastsound Water

- Eastsound Water will provide water to each Member of the Cooperative as equitably, without discrimination, and in compliance with applicable safe drinking water regulations and its water system
- 2. Eastsound Water will provide notice to all Members of any changes in the Bylaws and Operating Rules
- 3. Members may use as much water as desired, and can afford, provided they pay the applicable rates and charges set by the Operating Rules, and provided that the system as a whole can supply the needs of all Members. The Eastsound Water Board may adopt temporary water use restrictions in response to system emergencies, drought, or other interruption to a water source or water quality issues

Duties of the Member

- 1. The Member will pay all applicable fees and charges as outlined in the Eastsound Water Operating Rules
- 2. The Member will pay all water use service charges based on the rate structure outlined in the Eastsound Water Operating Rules include the current Water User rate structure and the Reasonable Water User Threshold policy
- 3. The Member acknowledges that the rates and fees may change during the lifetime of this Membership
- 4. The Member will immediately contact Eastsound Water if the Member discovers any problem with the Eastsound Water infrastructure, including tanks, lines, and meters
- 5. The Member will install and maintain equipment to protect all Members from any contamination of the water system from the Member's connection. This includes backflow protection and shut off valves on the Member side of the connection to Eastsound Water.
- 6. The Member agrees to only take water from fixtures downstream of the Eastsound Water's water meter associated with this Membership Agreement. NOTICE: This provision is a health & safety issue. A member violating this provision endangers the health and safety of water delivered to all other members
- 7. The Member will keep or allow Eastsound Water to maintain all water line easements on their property in a grassy and/or gravel covered state and will keep the meter setting accessible and free from plant
- 8. The Member will provide all water related fixtures downstream of the meter that are necessary to modify the water service to meet the Member specific (i.e. booster pumps, pressure relief valves, water filters, etc.).
- 9. The Member is obligated to pay all costs associated with system improvements or modifications that are necessary to serve their property including the extension of distribution mains along the property. Eastsound Water may choose to act as the lead contractor for any water system improvements required to provide service to the Member. Any water system improvements must use Eastsound Water methods, materials, and meet WA DOH and Eastsound Water standards. Any costs incurred to provide service or create service conditions satisfactory to the Member shall be borne by the Member. The Member is solely responsible for their actions and the actions of their contractors insofar as they affect any part of the water system.

- 10. The Member agrees to allow Eastsound Water to conduct inspection, maintenance, and repair activities on their property insofar as Eastsound Water infrastructure is located on their property
- 11. The Member agrees to complete a Cross Connection Control Survey prior to the activation of service and to conform to any applicable requirement of Eastsound Water's Cross Connection Control The presence of a well, an alternative water source, or a Cross Connection hazard on the property will require a backflow protection assembly to be provided by owner
- 12. The Member acknowledges that Eastsound Water may take actions, including restrictions on service or termination of service to protect the Membership if the Member does not fulfill their duties to the Association 13. The Member will maintain full and current contact information with the Association

General Terms of this Agreement

- 1. This Membership Agreement is entitled to one vote in any Eastsound Water election or proposed membership vote
- 2. Use of water in the Eastsound Water is conditional upon the availability of water. It is further conditional upon the terms of the Eastsound Water Bylaws, Eastsound Water Operating Rules, Eastsound Water Conditions of Service Governing the Use and Supply of Water, Eastsound Water Design and Construction Standards, the laws and regulations of San Juan County, and the State of Each of these may be amended in the future
- 3. The supply of water is governed by the availability of infrastructure, adequate water sources, production capability, and actions of the Washington Department of Health. A connection to Eastsound Water does not guarantee that water will be supplied in accordance with the Member's schedule
- 4. Through the general course of providing water, Eastsound Water will inspect, maintain, and repair Eastsound Water water infrastructure. As a result, service to the Member may be interrupted. There may be temporary variations in water quality as a result of treatment activities or minerals that exist in the raw waters
- 5. Eastsound Water will endeavor to meet or exceed all Washington State water quality standards

- 6. This Membership Agreement terminates on the sale or transfer of the property associated with this Agreement, a new allocation of Impact Units, or as specified in the Operating Rules
- 7. The San Juan County Fire Marshall should be consulted regarding San Juan County code specific to fire hydrant protection requirements for this property. If additional hydrant service is needed, consult with Eastsound Water to assist with planning
- 8. The Service Meter is/will be set at a location determined by Eastsound Water

The defective instructions and ballot can be best cured by recognizing that the individual receiving the third most votes taking seat 7.

Departures

Duke is off the board for two reasons. A. Because the seat he was holding expired in 2023 and B. because he was an appointee who did not file for the election.

Lancaster is off of the board because he was an appointee and must stand for election in 2023 even though seat 7 expires in 2024. Lancaster did not submit his name as a candidate.

Resignation

Joe Cohen resigned seat 4 on November 14, 2023, the day before the annual meeting. Whoever is appointed to fill seat 4 must stand for election in Nov 2024 for a seat that expires in 2025. Seat 4 was on the ballot in 2022, will be on the ballot in 2024 and will be on the ballot again in 2025.

EASTSOUND WATER USERS ASSOCIATION 2024 Board Transition Plan

Dear Members,

The Eastsound Water Board of Directors is committed and has always been committed to the best interests of our members. That includes delivering safe, high-quality water to our community and ensuring the

health and well-being of the Association and the employees who work on your behalf.

Your Board consists of seven volunteer, unpaid
Directors. Three Directors (Jim Nelson, Clyde Duke, and
Joe Cohen) have served over eight years, and one
Director has served over four years (Scott Lancaster).
Two Directors (Ron Clause and Michael Cleveland)
were newly elected and joined the Board effective
January 2023. One Director (Rick Christmas) was
recently appointed to the Board.

There are a number of operational and technical challenges, industry dynamics, and nuances faced by Board Directors that require a fair amount of institutional knowledge to be effectively actionable. Therefore, continuity of leadership and an every-evolving onboarding and education process is vital to the health of the organization.

The Board has discussed in prior years how to create a transition from the existing Board to new leadership, with considerations for balancing generational and institutional knowledge with better representation, inclusion and diversity. In the past year-and-a-half the Association has been implementing a thoughtful strategy to increase the long-term stability of Eastsound Water. This has had the great benefit of bringing more revenue home to fund capital projects and to reduce our rates, while creating more reliability for thousands of additional islanders.

Eastsound Water took over the daily management of the Doe Bay, Olga and three Rosario water systems with great success in 2022. By taking on these systems, we have been able to provide reliability to all of these systems by onboarding new operators here at home. In the process, we have gained new tools and certifications, and more experience in a range of diverse work situations. All of this has elevated the quality of our staff, our work-life balance, and has increased our redundancy and resiliency overall. In the past year we have expanded our reach from about 1,800 people to over 4,000 islanders, and at a positive net margin.

We have also expanded our tiny team of six full-time employees (three Operators, two Admin and a GM) just a few years ago – to a bright and proud group of

eleven (eight Operators, two Admin and a GM). And we are currently housing a portion of them and their families.

Procedural Considerations and Suggestions

Procedural considerations if the election is overturned

- The EWUA Board will have three out of seven board members until a new election is concluded.
 - Jim Nelson Vice President
 - Ron Claus
 - Mike Cleveland
- The bylaws require a board of seven directors.
 - Article VI.A.b. "The Board shall consist of seven (7) directors."
- The bylaws only provide for an election at the annual meeting which has traditionally been held every November.
 - Article VI.A.f "Elections At least two (2) and not more than three (3) Directors shall be elected at each annual meeting."
- The bylaws do not have any provision for the timing of a corrective election.
- The Annual meeting was held on November 15, 2023.
- After the 2023 election, Vice President Nelson took the role of President, Vice President, Secretary, and Treasurer, citing Article VI.E.c of the EWUA bylaws which only allows new officers to take office on January 1.
 - Article VI.E.c "At the first Board meeting following the annual meeting, the Board shall elect a President, Vice President and Secretary / Treasurer, from the Board membership, to serve for one (1) year commencing on January 1 of the next calendar year."
- State law RCW 24.03A.585(3) does not permit the president and secretary to be the same individual.

Suggested Procedural Directives

- Within ______ (10 suggested) days of this order, EWUA will elect interim officers from the remaining directors until a new election is held. These officers will immediately assume responsibility in compliance with the duties for each office subject to the State laws and subject to the bylaws.
- 2. Within _____ (15 suggested) days of this order, EWUA will announce a new election and call for candidates who want to be placed on the ballot.

| 3. | Within (30 suggested) days of this order, an independent party, selected by the EWUA Board, will be charged with conducting the election and provided with the following: |

| | vi. The tax parcel numbers associated with each Member. |

| 4. | Within (40 suggested) days of this order, the party conducting the election on behalf of EWUA will produce and send a ballot to all Members to vote on for their choice of directors. The ballot will be sent by snail mail for the Members who have not provided an email address. |
| 5. | Each ballot will be unique and include the Member's name, the Member account number, the tax parcel numbers associated with that Member, and the number of votes that Member is entitled to cast. |
| 6. | The ballot will be secured such that only the Member and the independent election |
| 7. | inspector can access the Member's ballot. Within (30 suggested) days of this order, EWUA will simultaneously provide any |
| 8. | Member who asks for it the same information as provided to the independent party conducting the election, with the exception of the Membership's email addresses. The ballot will allow the voters to select four directors for the four seats that were open or vacant as of November 15, 2023. The vacancy caused by the resignation on November 14, 2023 occurred prior to the annual 2023 meeting. Hence, as per the bylaws, the seat will be filled by election. Article VI.A.f of the bylaws is overruled for this special corrective election. |
| 9. | As there are no quorum requirements, EWUA will not cast any proxy votes on behalf of any Members in the election. |
| 10. | Within (60 suggested) days of this order, the election for four seats will be concluded and the results announced. |
| 11. | The newly-elected members will be immediately seated. |
| 12. | Within (10 suggested) days of the conclusion of the corrective election, the EWUA Board will hold an election of officers, and those officers will take office immediately upon being elected. |

- 13. This special corrective election does not replace the regular annual November 2024 election and Annual meeting.
- 14. The two highest receiving vote recipients will fill seat 1 and seat 2 and have a term expiring at the annual meeting in 2026.
- 15. The third highest receiving vote recipient will fill seat 4 and have a term expiring at the annual meeting in 2025.
- 16. The fourth highest receiving vote recipient will fill seat 7 and have a term expiring at the annual meeting in 2024.
- 17. During the interim period, between this order and the seating of the members elected by the corrective election, the three-member Board will undertake only essential business which may include paying routine bills and revoting the sales of water memberships made between November 15, 2023 and the date of this order.
